You have been identified as having previously been terminated from Medicaid due to the termination of Supplemental Security Income (SSI) benefits. You were receiving Medicaid benefits as a recipient of SSI. (See 42 CFR § 435.120). This letter is to inform you that your Medicaid benefits may have been improperly terminated when your SSI was terminated.

J.M. et al. v. Crittenden, et al. (U.S.D.C. Northern Dist. Ga. 1:18-cv-568) is a federal class action lawsuit filed in 2018 on behalf of Medicaid beneficiaries in Georgia who were receiving SSI Medicaid benefits because they were receiving Supplemental Security Income ("SSI") benefits. The case concerns alleged improper redeterminations of Medicaid eligibility (commonly referred to as "continuing Medicaid determinations") for Medicaid Home and Community Based Services (HCBS) Waiver recipients as well as children under 19 years of age who are terminated from Medicaid.

You are receiving this Notice because you have been identified as a possible Class Member who may have been entitled to a redetermination of Medicaid eligibility.

If you are currently receiving Medicaid benefits, you do not need to take any action. Your Medicaid benefits will continue.

However, if you did not reapply for Medicaid or did not begin receiving Medicaid benefits again, you may be eligible to receive Medicaid and should consider re-applying for Medicaid. You may apply by any of the following methods:

- Complete a Medicaid application online at https://medicaid.georgia.gov/how-apply
- Begin a phone application by calling 877-423-4746, please provide the date of this letter to the call center agents that will assist you; or
- Apply in person at a Department of Human Services Division of Family and Human Services (DFCS) office. A list of DFCS offices is below.

If you are a child 18 years of age or younger and have any of the following:

- an intellectual or developmental disability,
- a disability that requires ongoing care from a skilled nurse, occupational therapist, physical therapist, or speech-language pathologist,
- a disability that requires Applied Behavioral Analysis (ABA) therapy,
- a disability that sometimes requires hospitalization, or
- a disability that impairs your ability to care for yourself such as bathing, dressing, feeding, or toileting

then you may qualify for Katie Becket Medicaid (a.k.a., the Deeming Waiver). Unlike the other types of Medicaid, there are no income limits to qualify for Katie Beckett Medicaid. To apply to
