

## PUBLIC NOTICE

Pursuant to 42 C.F.R. § 447.205, the Georgia Department of Community Health is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

### BIOMARKER TESTING COVERAGE

The Department of Community Health (DCH) proposes to update the Medicaid and Peachcare for Kids coverage package to allow for biomarker testing as medically necessary. Effective date for the change will be September 15, 2023 pending final Board approval. Biomarker testing means the analysis of a patient's tissue, blood, or other biospecimen for the presence of an indicator of normal biological processes, pathogenic processes, or pharmacologic responses to a specific therapeutic intervention. Such term includes, but is not limited to, gene mutations, protein expression, known gene-drug interactions for medications, and characteristics of genes.

DCH will open Current Procedural Terminology codes 0037U, 0239U, 0172U, and 0345U for coverage. All biomarker testing codes will be open at eighty percent (80%) of the third quarter 2023 Clinical Diagnostic Laboratory Fee Schedule.

The change in methodology will result in an increase in State funded expenditures allocated by the Georgia Legislature in the 2023 legislative session as follows:
