Pursuant to 42 C.F.R. § 447.205, the Georgia Department of Community Health is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

# COMPREHENSIVE SUPPORTS WAIVER PROGRAM (COMP) AND NEW OPTIONS WAIVER (NOW) PROGRAM AMENDMENTS

Pending Department of Community Health (DCH) Board and Centers for Medicare and Medicaid Services (CMS) approval, DCH proposes to amend the NOW and COMP waivers effective November 10, 2023.

DCH proposes to sustain targeted rates within the waivers determined previously through the Appendix K which ends November 11, 2023. Proposed rate increases will be initially funded through American Rescue Plan Act Funding (ARPA). Following exhaustion of ARPA funding the state match for rate increases will be financed through the Department of Behavioral Health and Developmental Disabilities.

# **Additional Modifications**

DCH proposes to modify the waivers to allow for the Appendix K provision continuing family caregiver hire for legally responsible person, relative and legal guardian for Community Access, Community Living Support Services, Supported Employment Services and Transportation Services. Public guardians cannot serve as family caregiver hires. Legally responsible persons can only provide these services when they constitute care over and above that which a legally responsible person would ordinarily provide.

This public notice is available for review at each county Division of Family and Children Services office. An opportunity for public comment will be held on **September 21, 2023 at 11:00 a.m., via Zoom audio**. There will be **no in-person** attendance at the Department of Community Health (DCH).
