- R1- Kinship Care Month, GPHSA Conference- Region 1 basket raised the most money, Gordon County DFCS Board was named Board of the Year, 71 children enter foster care during August
- R2 Trying to retain and hire staff, Employee received 2 awards from the Commissioner's staff awards
- R3 Paulding and Douglas piloting mCase, newly formed adoption unit, hiring needs
- R6 Toys for Tots provided bags for every foster child in Region 6, hired County Directors
- R8 Muscogee County had a backpack giveaway with school supplies for children in care, Sumter County received backpacks as well, 16 counties in Region 8 are holding meet and greets with law enforcement, staff vacancies
- R9 Started internal case quality review process, struggling with qualified applicants, Regional Director position opening
- R10 New Region Director, progress with hiring and filling positions, spotlighted for State Kinship Program
- R11 Progress with Court Orders, few counties which are fully staffed, still several counties that are not, challenges with children involving both DFCS and DJJ

- R12 Needs with leadership vacancies, rebuilding relationships between families and the Department, HR work to expedite onboarding process, Chatham County developing Restoration Savannah, Trunk or Treat October 28th for foster children and families
- R13 Region Advisory Meeting, Rental Cars without gas cards for workerswaiting for reimbursement, building more support for staff based on exit survey responses
- R14 Deputy Director of DeKalb County DFCS shoutout, Saturday September 24th DFCS with CASA school supply drop off, adoption numbers are lower than this time last year
