### What potential services will the group be considering as we work on the list of recommended services?

Family First services must be chosen from among the evidence-based practices (EBP's) rated on the Title IV-E Prevention Services Clearinghouse at https://preventionservices.abtsites.com/.

Services are rated on the Clearinghouse as well-supported, supported, promising, or does not currently meet criteria. The initial implementation of Family First in Georgia will focus on well-supported services.

#### How will this group go about reviewing & recommending services?

Each service under consideration will be rated on multiple criteria related to fit and feasibility. Fit refers to how well the service would meet the needs of families, children and youth in the population to be served, and feasibility refers to the level of effort that would be required to implement/bring the service up to scale.

Prior to each group meeting, the Family First team along with Chapin Hall will do an in-depth review of relevant data and use the information from that review to assign a criteria rating to each service. The data, ratings, and thought process behind each rating will then be presented to the workgroup at meetings. Workgroup members will give their feedback on service ratings using interactive, in-meeting polls.

The ratings and member feedback will be used to create a list of recommended services that will then be reviewed and validated by the group.

#### How is this workgroup related to implementation of Family First Serivces?

This workgroup is undertaking a process to inform recommendations for Family First EBPs for Georgia's Title IV-E Prevention Plan. The implementation, procurement and contracting

processes are completely separate. Participation in this workgroup has no influence on future contracting opportunities. We appreciate the shared expertise of our partners to assist the state in selecting services that will benefit children and families.

#### How do group homes fit into Family First services?

The federal legislation specifies that Family First EBP's are for children and youth who are at imminent risk of coming into foster care, which in Georgia we are defining as children and youth being served in Family Preservation. Because they are being served in Family Preservation and not foster care, these children and youth will not be group home residents.

## Will EBP's be evaluated through an anti-discrimination lens? Can the chosen EBP's be modified to fit the needs of particular populations/subpopulations?

Much of the available literature focuses on EBP support and effectiveness across cultural and racial groups. The Family First team, Chapin Hall, and the workgroup do seek to evaluate EBP's through the broadest possible anti-discrimination lens possible, and recommending EBP's to fit the very diverse population to be served.

Because Family First EBP's must be chosen from among those rated on the Clearinghouse, any modifications must be part of a model version that is rated on the Clearinghouse.
