

## PUBLIC NOTICE

Pursuant to 42 C.F.R. § 447.205, the Georgia Department of Community Health is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

### Georgia Pediatric Program (GAPP) Rate Increase

Effective July 1, 2022 with DCH Board approval, the Department of Community Health (DCH) is proposing an increase in rates of reimbursement for pediatric in home skilled nursing covered by GAPP. The increase in rates of reimbursement is funded in accordance with the DCH American Rescue Plan of 2021 (ARP) and supported ongoing by State appropriations.

Proposed July 1, 2022 rates are as follows:
