

## PUBLIC NOTICE

Pursuant to 42 C.F.R. § 447.205, the Georgia Department of Community Health is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

### GROUND AMBULANCE UPPER PAYMENT LIMIT (UPL)

Pending Centers for Medicare and Medicaid Services' (CMS) approval and effective for services provided on or after August 13, 2021, the Department proposes to modify the average commercial rate calculation and frequency of data collection used in the calculation of ambulance supplemental payment.

This change is estimated to increase supplemental payments by:

Effective July 1, 2020 the Department implemented a supplemental payment program for hospital based or government affiliated Fee-for-Service ground ambulance providers. The State Plan Amendment required ambulance providers to submit three to five commercial payer rates for the calculation of the average commercial rate. Several rural ambulance providers could not provide the three commercial rates for the required Healthcare Common Procedure Coding System (HCPCS) codes for the calculation. These rural ambulance providers did not receive a supplemental payment for those HCPCS codes. Effective August 13, 2021, the State will modify the state plan to apply a median rates per HCPCS code in lieu of commercial rates for these providers.

Secondly, to improve efficiencies for both the ambulance providers and State, the State will modify the state plan language to allow ambulance providers to submit commercial rates every two years instead of twice per year.

This public notice is available for review at each county Division of Family and Children Services office. An opportunity for public comment will be held on **August 17, 2021 at 11a.m., via WebEx audio**. There will be **no in-person** attendance at the Department of Community Health (DCH).
