

## PUBLIC NOTICE

Pursuant to 42 C.F.R. § 447.205, the Georgia Department of Community Health is required to give public notice of any significant proposed change in its methods and standards for setting payment rates for services.

### Increase Rate for Long-Term Acute Care Hospitals (LTAC) and Inpatient Rehabilitation Facilities (IRF)

Pending enactment of HB 911, and approval by the Centers for Medicare and Medicaid Services (CMS), the Department of Community Health (DCH) proposes a ten percent (10%) increase to Long-Term Acute Care Hospitals (LTAC) and Inpatient Rehabilitation Facilities (IFR) reimbursement rates effective July 1, 2022.
