## NEWBORN SCREENING RATE INCREASE

Pursuant to House Bill 68 (HB68) enacted during the 2025 legislative session and pending approval by this Board and the Centers for Medicare and Medicaid Services (CMS), the Department of Community Health (DCH) proposes to increase the reimbursement rate for the Department of Public Health (DPH) for newborn screening.

This rate increase reflects the inclusion of an additional disorder approved by the Georgia Newborn Screening (NBS) Advisory Committee, effective August 1, 2025.

The cost impact is as follows:

	State Funds	Federal Funds	Total Funds
SFY 2026	\$138,813	\$273,218	\$412,031

DPH has historically administered the state's NBS program and will continue to maintain oversight of the screenings. Starting August 1, 2025, DPH will begin screening for Krabbe disease, an addition to the newborn screening program. Our current newborn screening (NBS) fee is \$80.40 and the addition of Krabbe to the NBS panel will result in an increase of \$7.93. The FY 2026 NBS fee will be \$88.33.

This public notice is available for review at each county Division of Family and Children Services office. An opportunity for public comment will be held on **August 18, 2025, at 11:30 a.m., via Zoom audio**. There will be **no in-person** attendance at the Department of Community Health (DCH).
