Increase Supplemental Quality Incentive Payments to Eligible Nursing Facilities

Pending Centers for Medicare and Medicaid Services (CMS) approval, the Department of Community Health (DCH) proposes to increase supplemental quality incentive payments to eligible nursing facilities effective July 1, 2021.

This change is estimated to increase funding for eligible nursing facilities.

The FY 2022 Appropriation Bill (HB81) includes funding for the Department to increase supplemental quality incentive payments to eligible nursing facilities. The Department collaborated with internal and external stakeholders to develop the following quality incentives.

3. Infection Control Specialist

DCH recommends that all nursing facilities hire and retain an Infection Control Specialist. An Infection Control Specialist includes the following: Infection Preventionist, Infection Control Nurse, Registered Nurse Infection Preventionist, or an Infection Control and Preventionist.

The Infection Control Specialist must be a full-time permanent position. The individual must be certified by the Board of Infection Control and Epidemiology and possess the CIC Certificate.

Acceptable training and education include: Post-Secondary Education in a health-related field including, but not limited to, medicine, nursing, laboratory technology, or public health, and two (2) years of experience in infection prevention and control. This experience must include the identification of infectious disease processes, surveillance, Epidemiology investigation, and preventing and controlling the transmission of Infectious Agents.

4. Adjustments to Clinical Measures

DCH recommends the following clinical measures be removed from the Quality Incentive Program as CMS is no longer tracking or monitoring them as quality metrics:

- a. Percent of long-stay residents who have moderate to severe pain; and
- b. Percent of short-stay residents who have moderate to severe pain.

DCH recommends the following clinical measure be adjusted to reflect the current terminology:

a. Percent of short stay residents with pressure ulcers, new/worsened will be changed to:
Changes in Skin Integrity Post-Acute: Pressure Ulcer/Injuries, to include the addition of new
or worsened unstageable pressure ulcers.

Number of facilities impacted can change as quarterly data is updated.
