






#### Recurrence of Substantiated Child Maltreatment (Jan 2013 – Jan 2014)



#### Disposition of Child Abuse and Neglect Reports (January 2014)





#### **Number of Child Placement Services Cases (January 2014)**




### Number of Children in the Custody and Care of DFCS (January 2014)




#### Children in the Legal Custody of DFCS Under the Age of 18 (January 2013 - January 2014)




#### Extended Youth Services (January 2013 - January 2014)


Def: Number of children age 18 and over who have signed themselves back into care.



#### Comparison of Foster Care Entries and Exits (January 2013 - January 2014)




## Foster Care Re-Entry Rate (January 2013 - January 2014)




#### Length of Time to Reunification (January 2013 - January 2014)
