SAFETY: Children are first and foremost, protected from abuse and neglect.

Outcome I: Child Protective Services Cases

Count of unique CPS Investigations and Family Preservation (Ongoing) stages open at any point during the month. Includes all cases active at some time during the month. Outcome is calculated 45 days prior to the date of report.

Outcome 1A: Family Support Cases Only: Count of unique Family Support stages open at any point during the month.

Outcome 1B: Investigation Cases Only: Count of unique Investigation stages open at any point during the month.

Outcome 1C: Family Preservation Cases Only: Count of unique Family Preservation stages open at any point during the month.

Outcome II: Recurrence of Substantiated Child Maltreatment

Of all the children who were victims of substantiated maltreatment in the first 6 months of the year, the percentage that had substantiated maltreatment within the following 6 months. Outcome is calculated 45 days prior to the date of report. Each month is calculated as a rolling calendar year. *National Standard: less than or equal to 5.40%*

Chart reflects the disposition of reports received in a particular month. Data includes count of Family Support, Substantiated Investigations, Unsubstantiated Investigations and Screen-outs. Outcome is calculated 45 days prior to the date of report.

Chart reflects the disposition of investigations received in a particular month by the subsequent case type. Outcome V: Number of Child Placement Services Cases

Count of unique children who were involved in an open Foster Care or Adoption stage during the month. In placement services each child who is the principal (PC) is considered a case.

Count of unique children who were in the legal custody of DFCS (17 years of age and under) at some point during the month, and those 18 years of age and older (Extended Youth Services). Excludes Aftercare, ICPC, Placement services to parents, and Boarding County. Source: SHINES

Outcome VI - A: Children in the Legal Custody of DFCS Under the Age of 18 (Regional)

Count of unique children who were in the legal custody of DFCS (17 years of age and under) at some point during the month, and those 18 years of age and older (Extended Youth Services). Excludes Aftercare, ICPC, Placement services to parents, and Boarding County.

Outcome VII: Comparison of Foster Care Entries & Exits

Number of children who have entered foster care and number of children who have exited foster care during the month. Total children at end of month show the number of children on the last day of the month. Source: SHINES

Outcome VIII: Foster Care Re-entries

Of all the children who entered foster care, the percentage that were discharged from a prior episode of foster care within 12 months of the current foster care placement. National Standard: less than or equal to 8.60%.

Percentage of children who exited care during the month through reunification with their family that reunified in less than 12 months from the date of their removal. National Standard: greater than or equal to 76.20%

State Target: greater than or equal to 30.00%

Outcome XIV: Stability Performance Coefficient (Number of Moves/Number of Days in Custody * 1000)

A calculated value based upon the ACF CFPS Round 3 which is part of Program Improvement. It is calculated from a rolling 12 month population of the entry cohort where the child remained in custody for over 8 days and was not 18 on the date of removal. The ACF Target is: 4.12 to avoid PIP. Georgia's Program Improvement Plan Target is: 6.01.

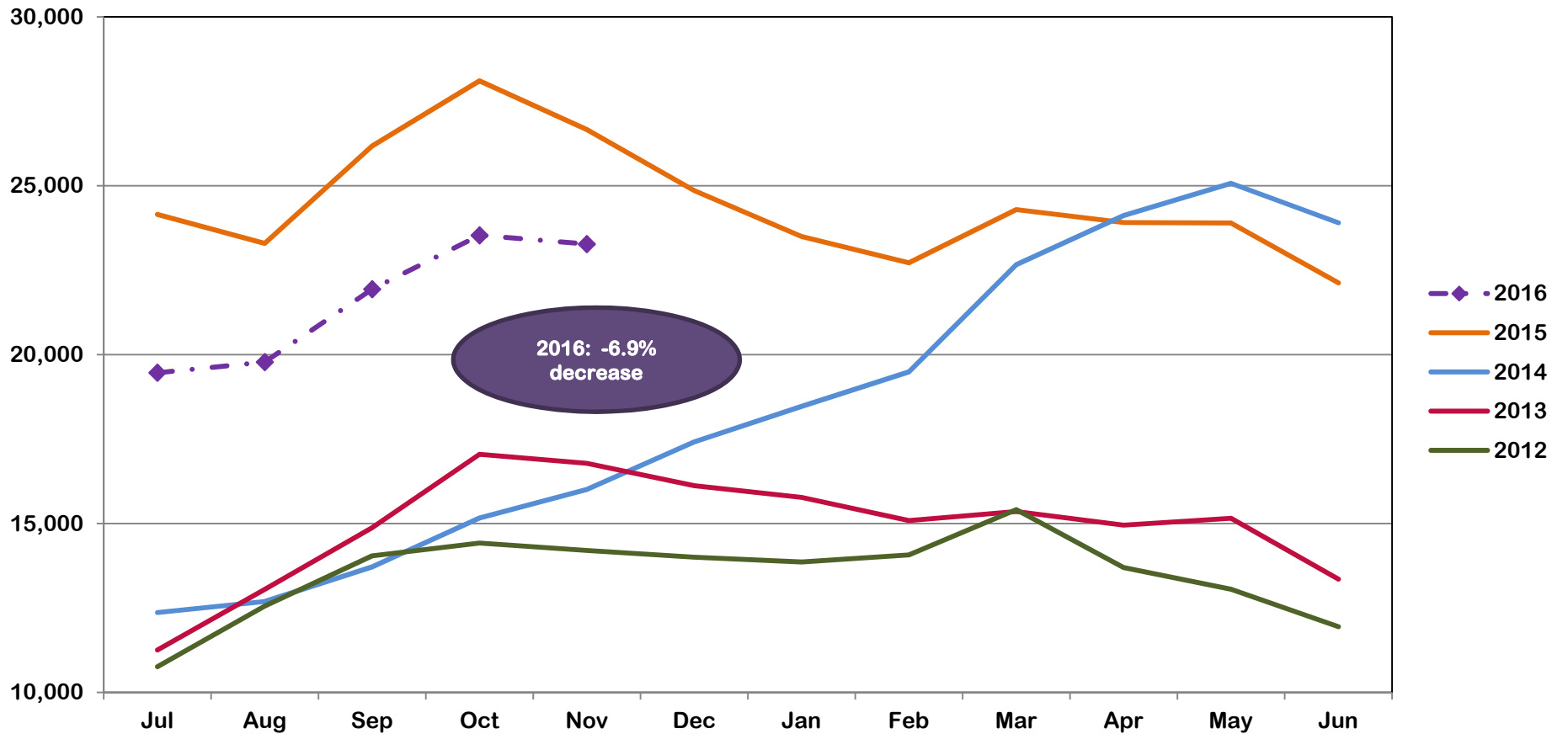

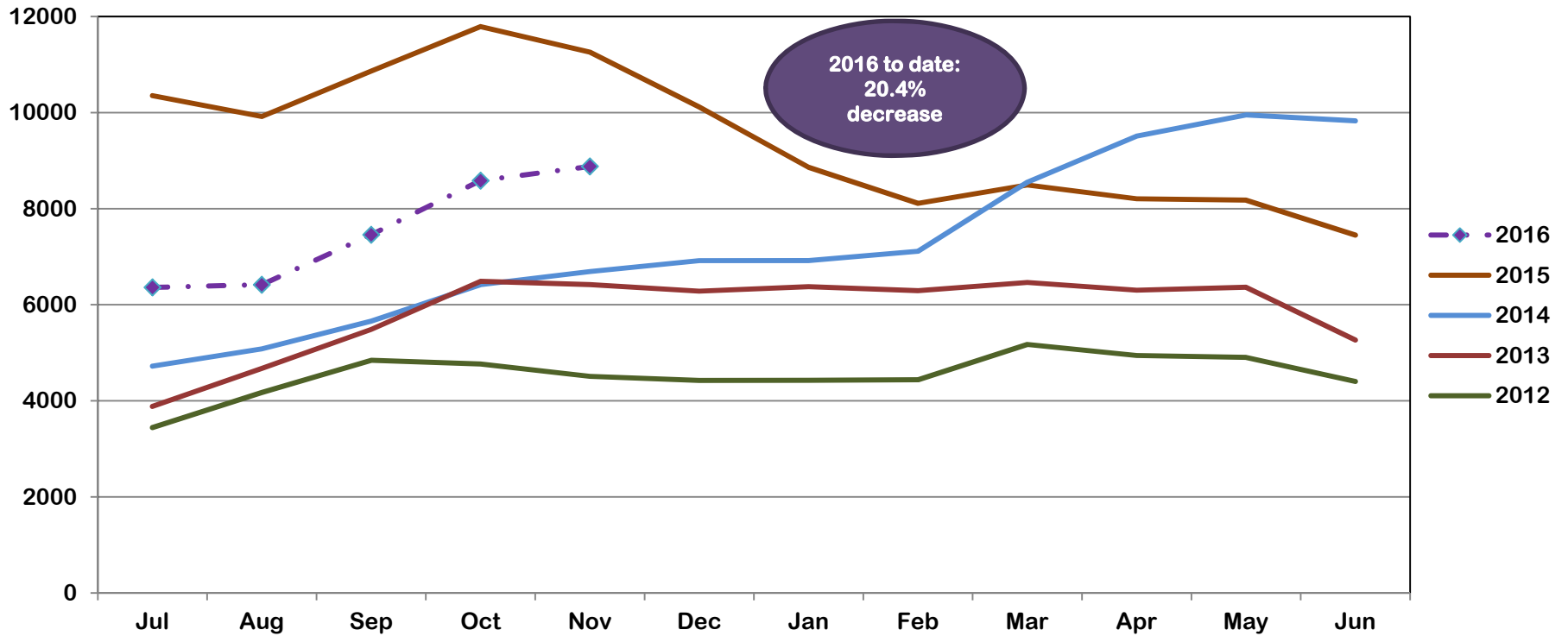

Outcome I: Child Protective Services Cases (November 2015)



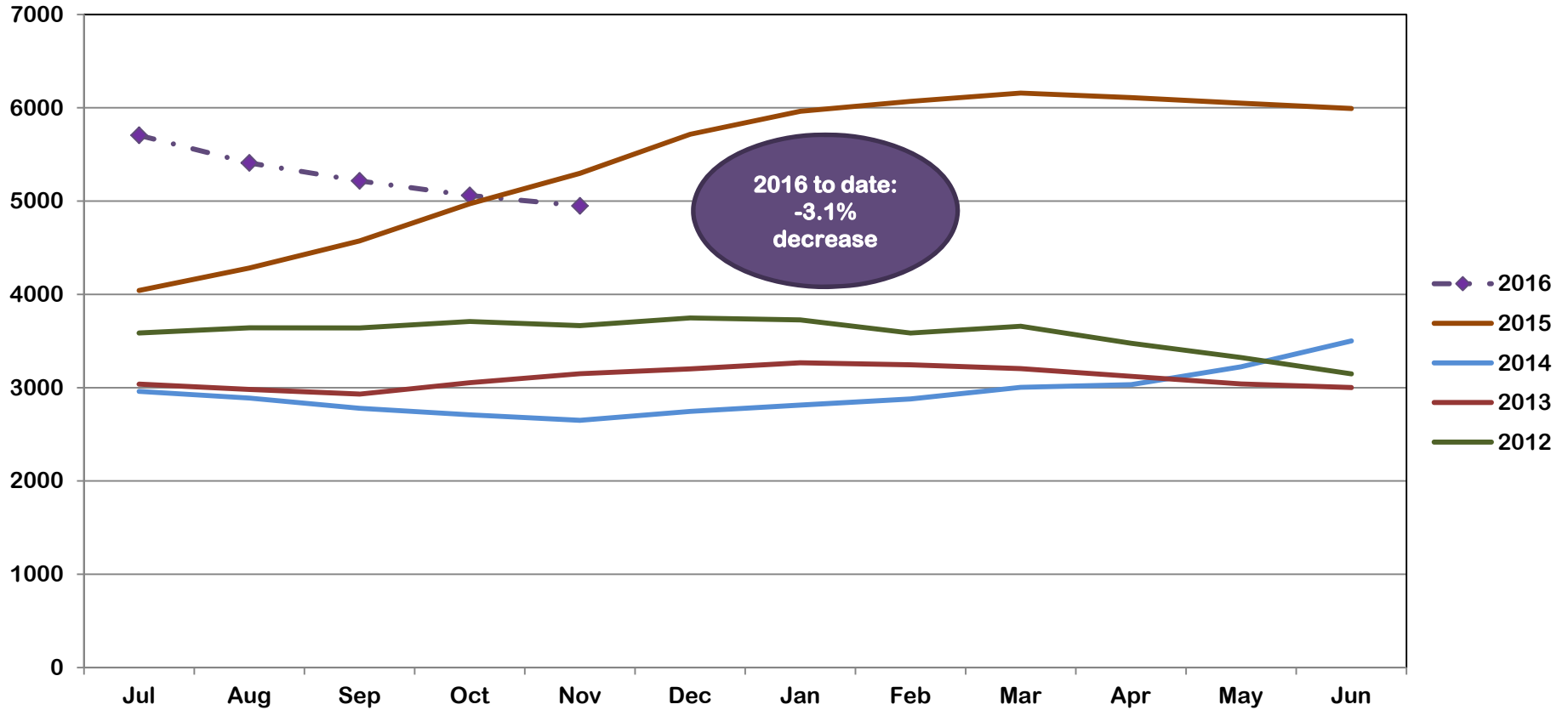

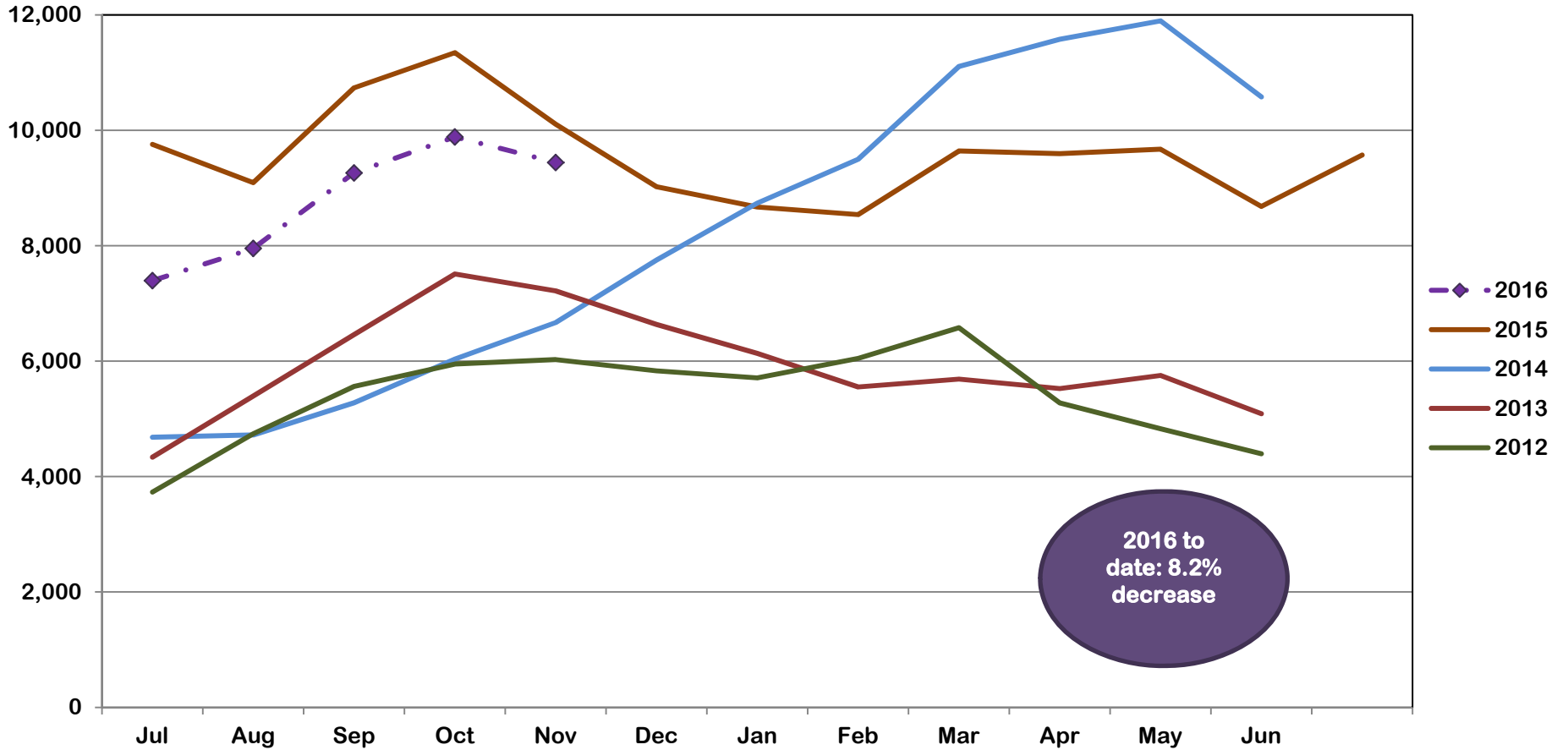

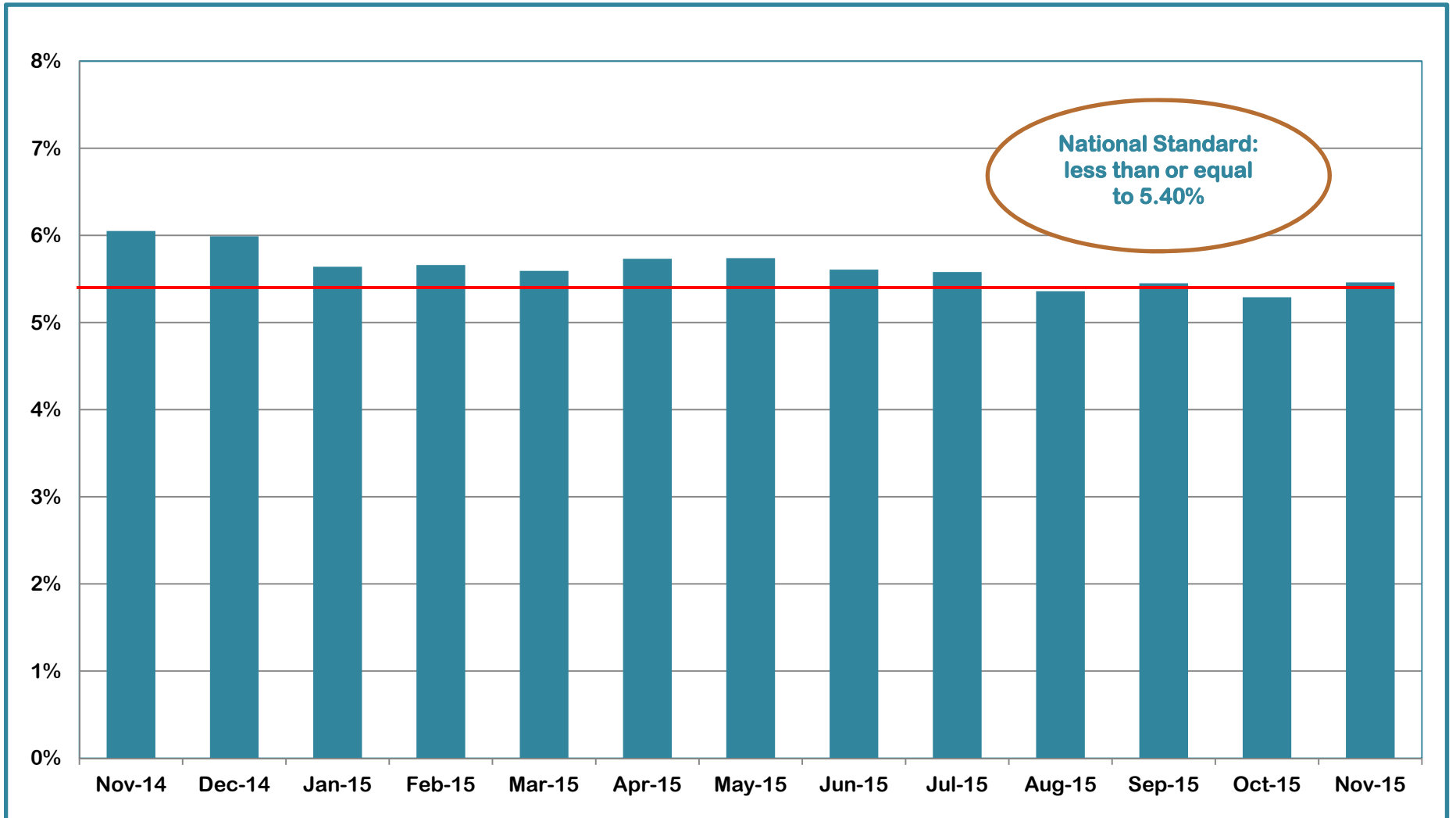

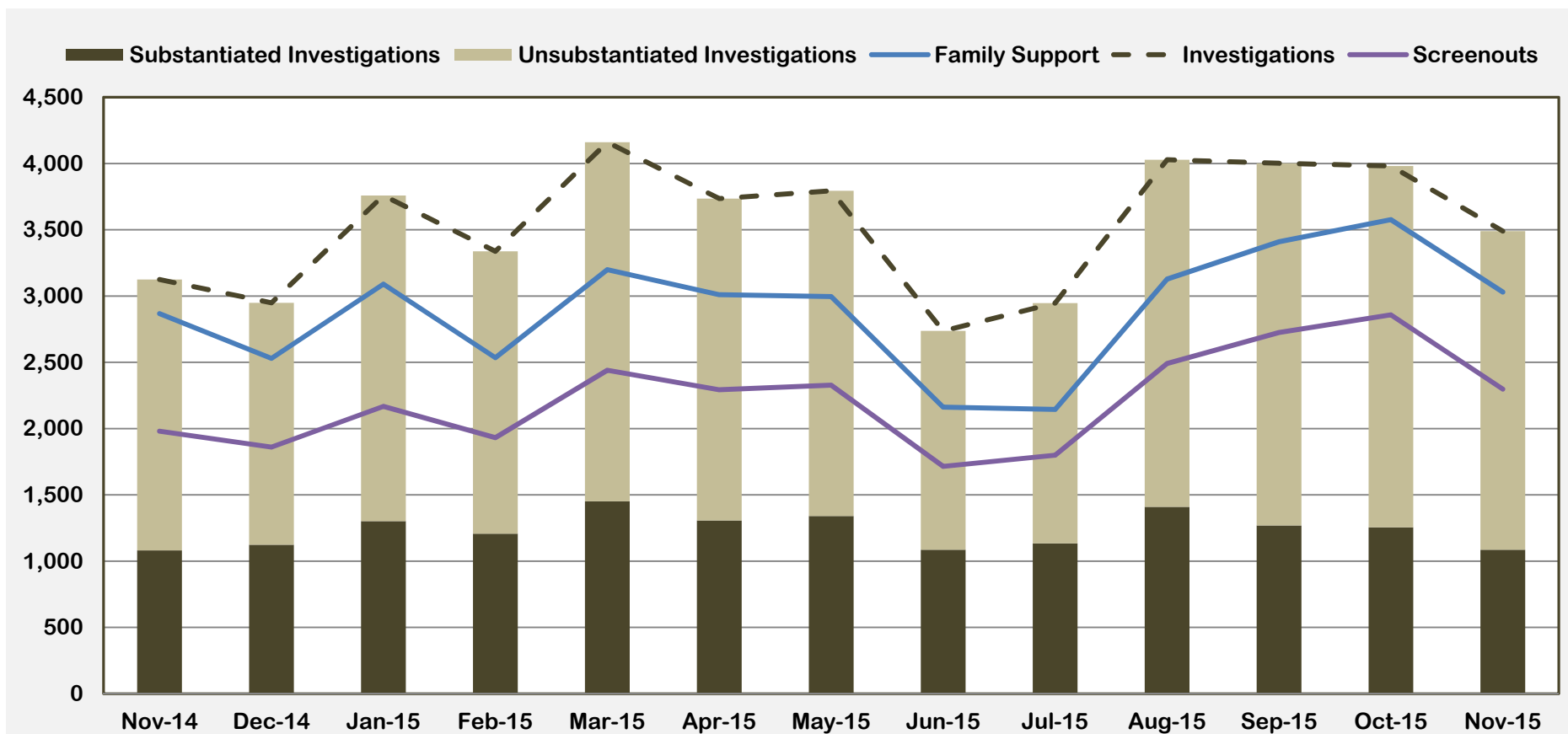

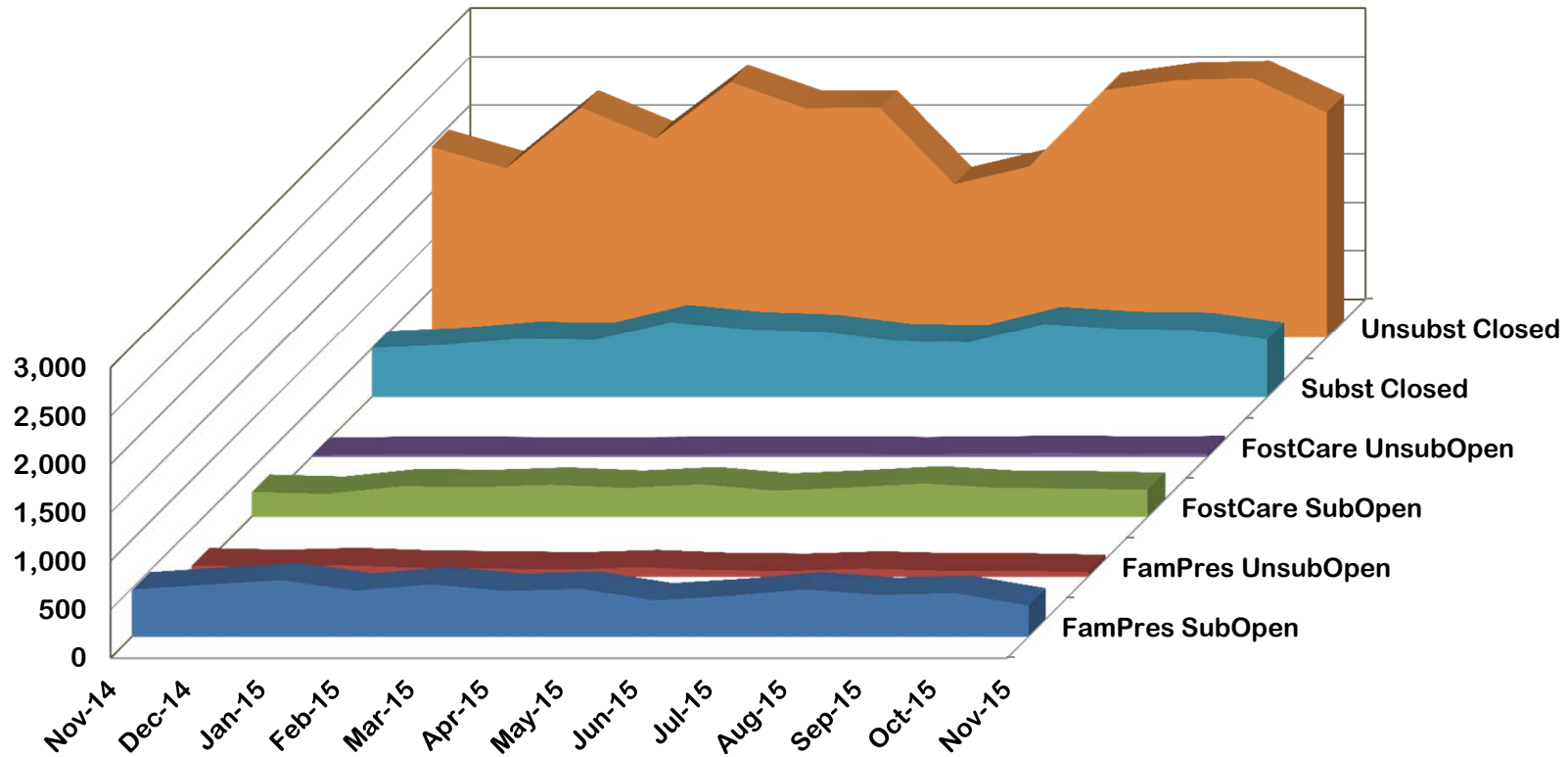

Outcome III: Disposition of Child Abuse and Neglect Reports (November 2014 - November 2015)



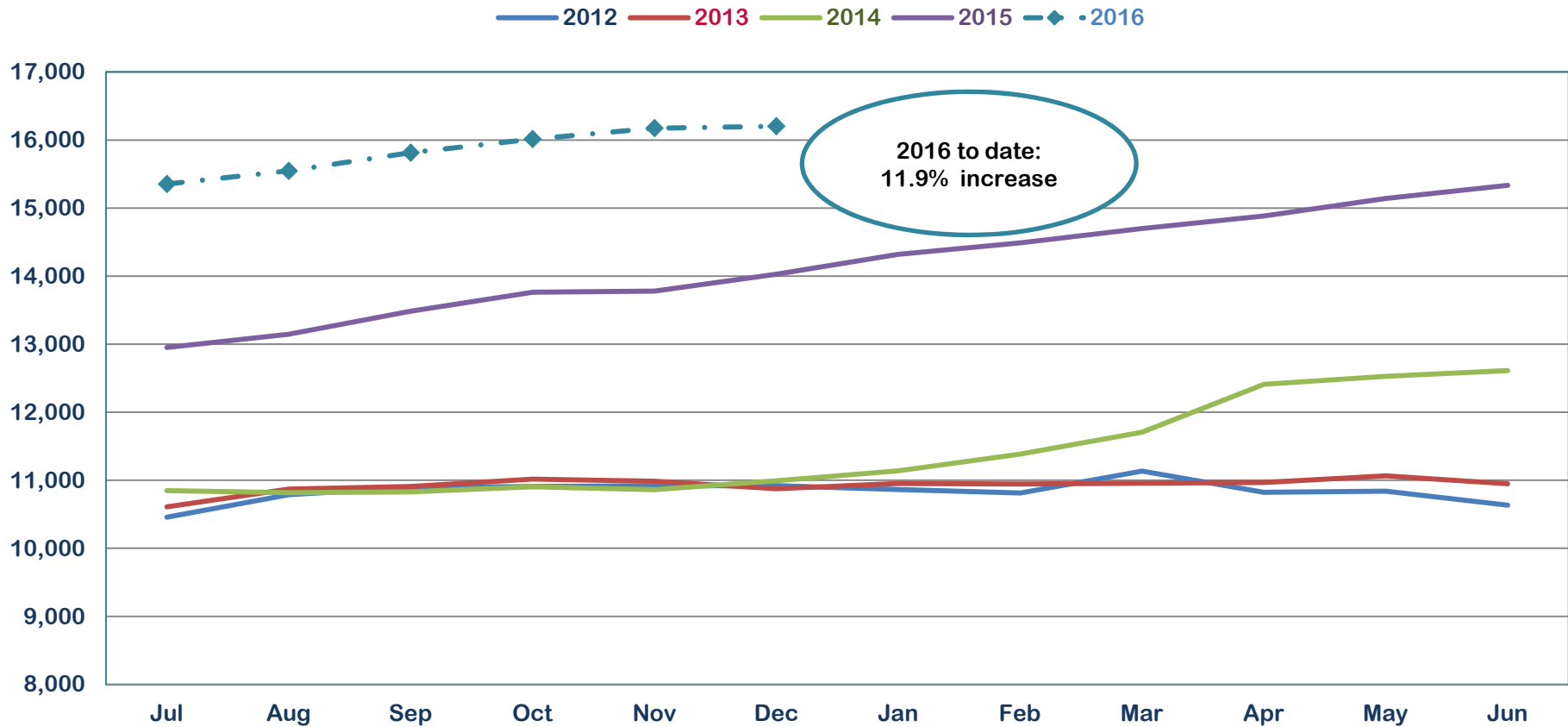

Outcome IV: Subsequent Case-Types of Investigations (November 2014 - November 2015)



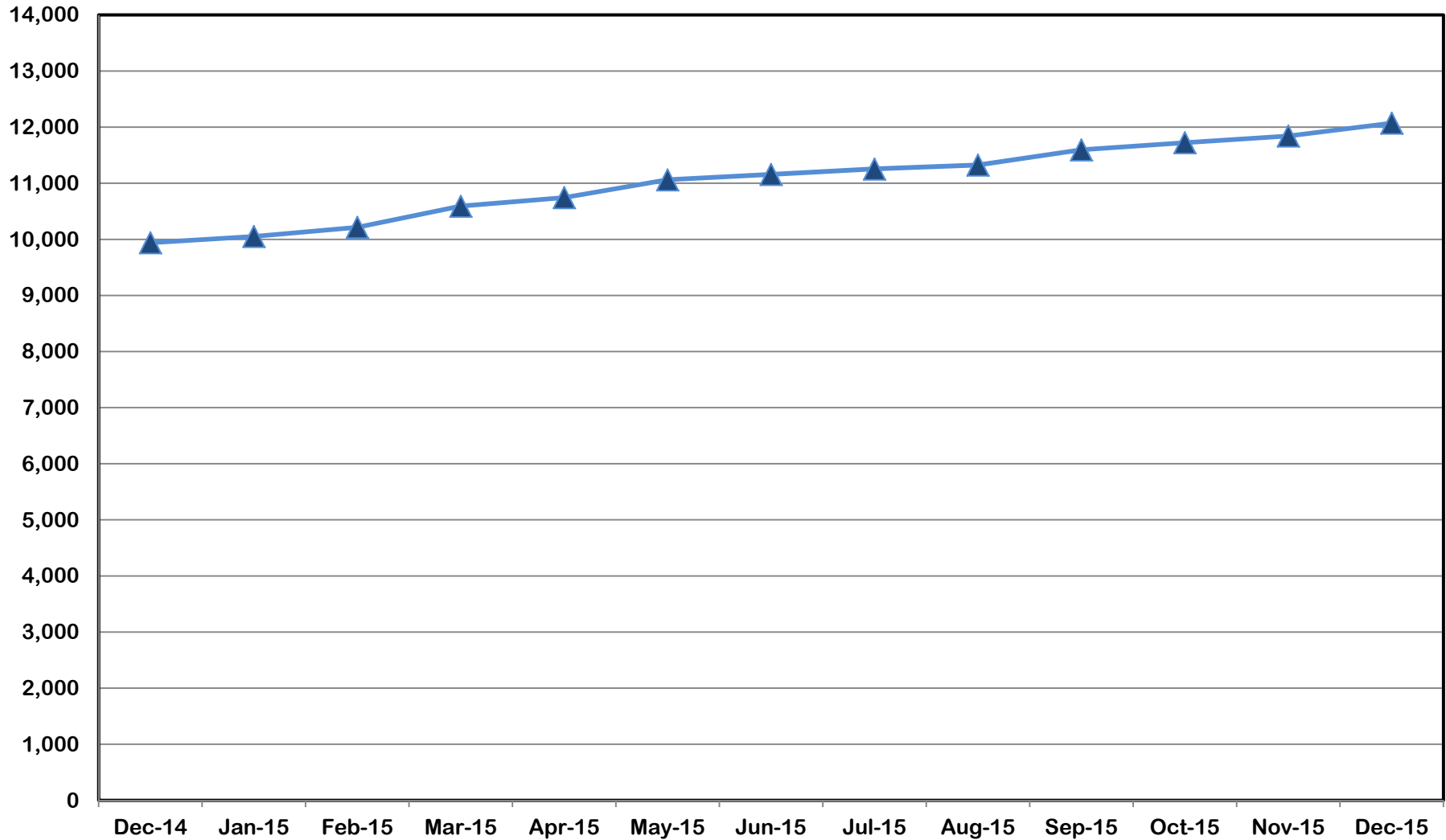

Outcome V: Number of Children in Placement Services (State Fiscal Year 2016)



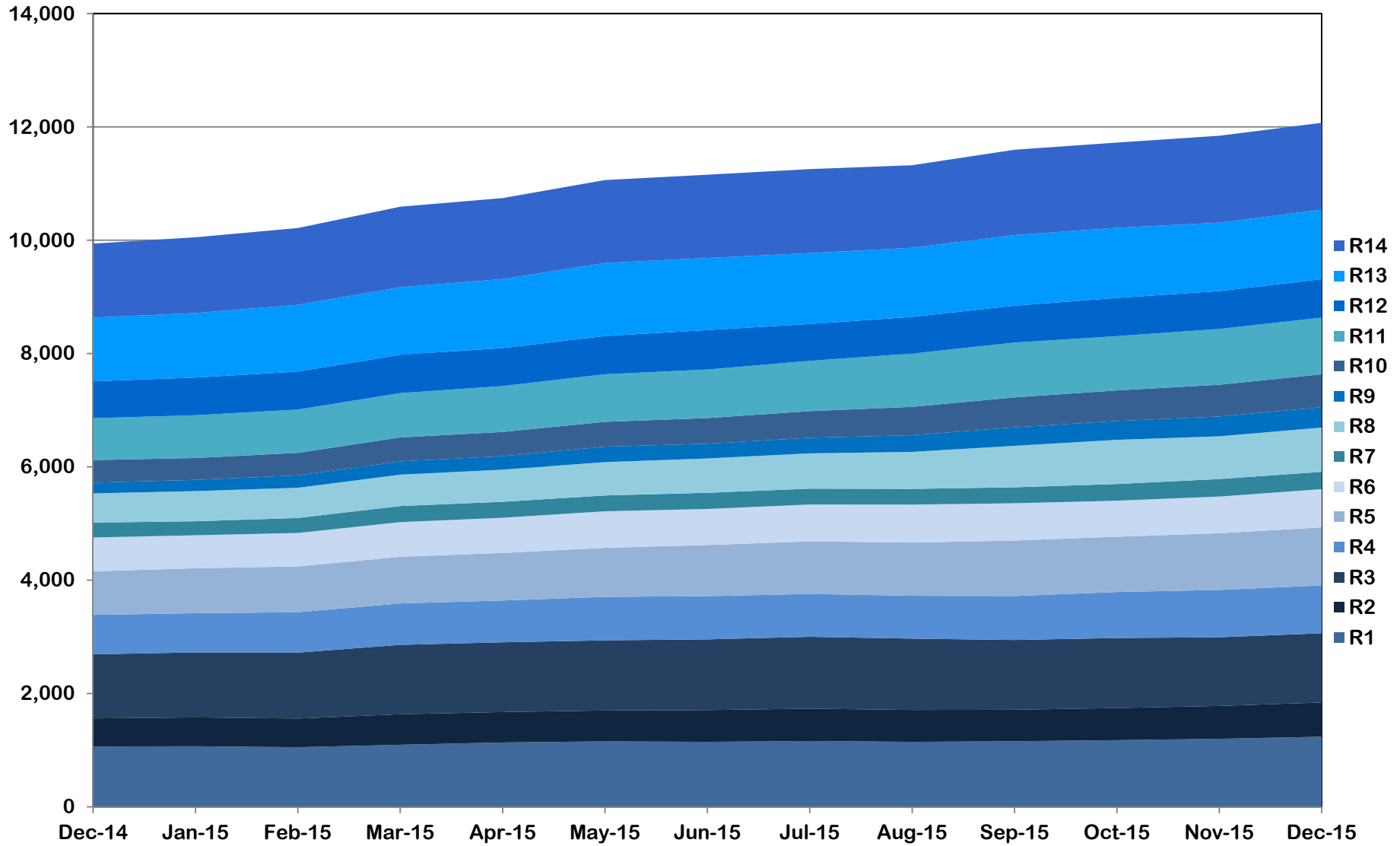

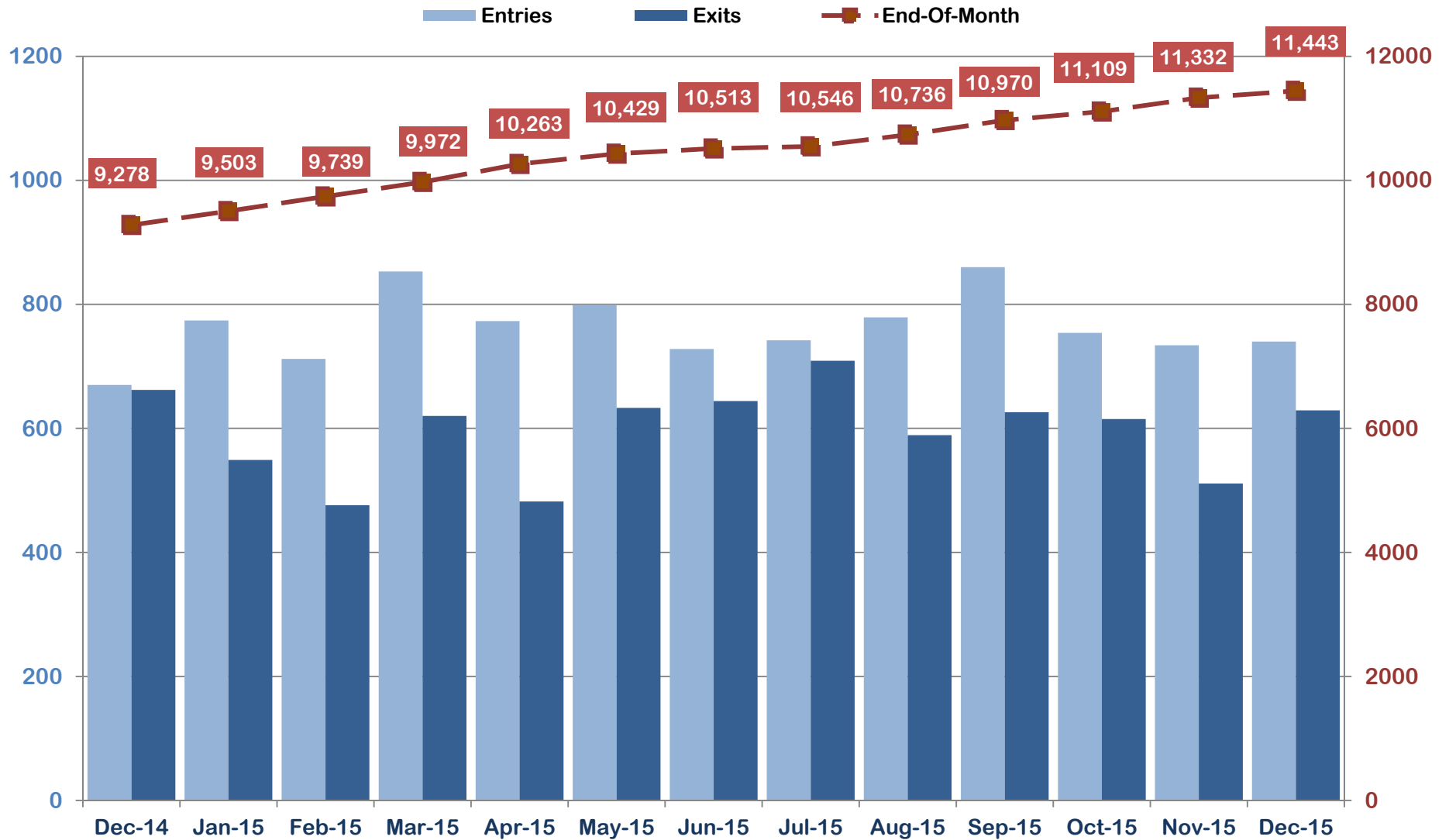

Outcome VI-A: Children in DFCS Custody Under the Age of 18 - (Regional) (December 2014 – December 2015)

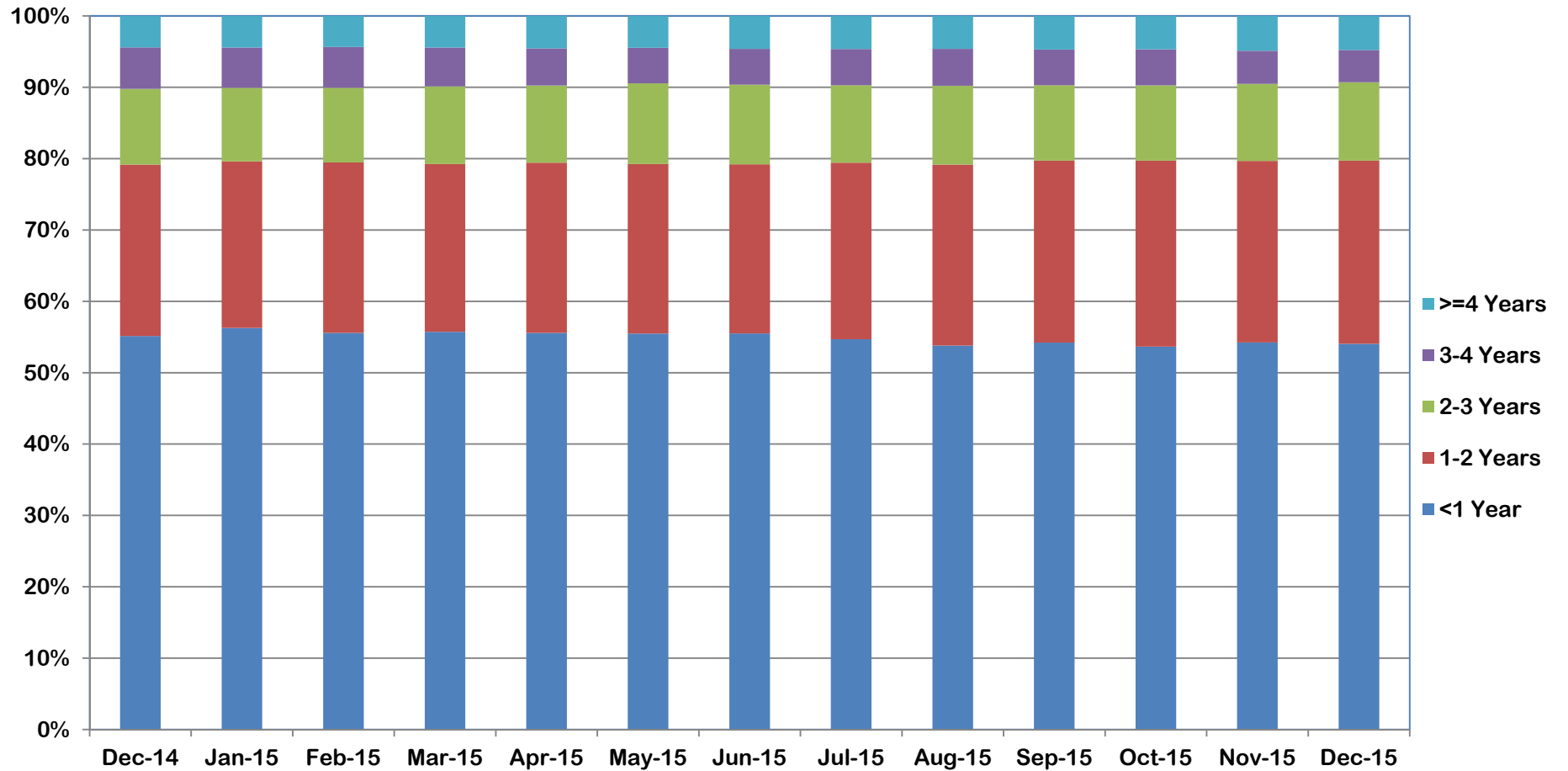


Outcome VII: Foster Care Re-Entry Rate (December 2014 – December 2015)



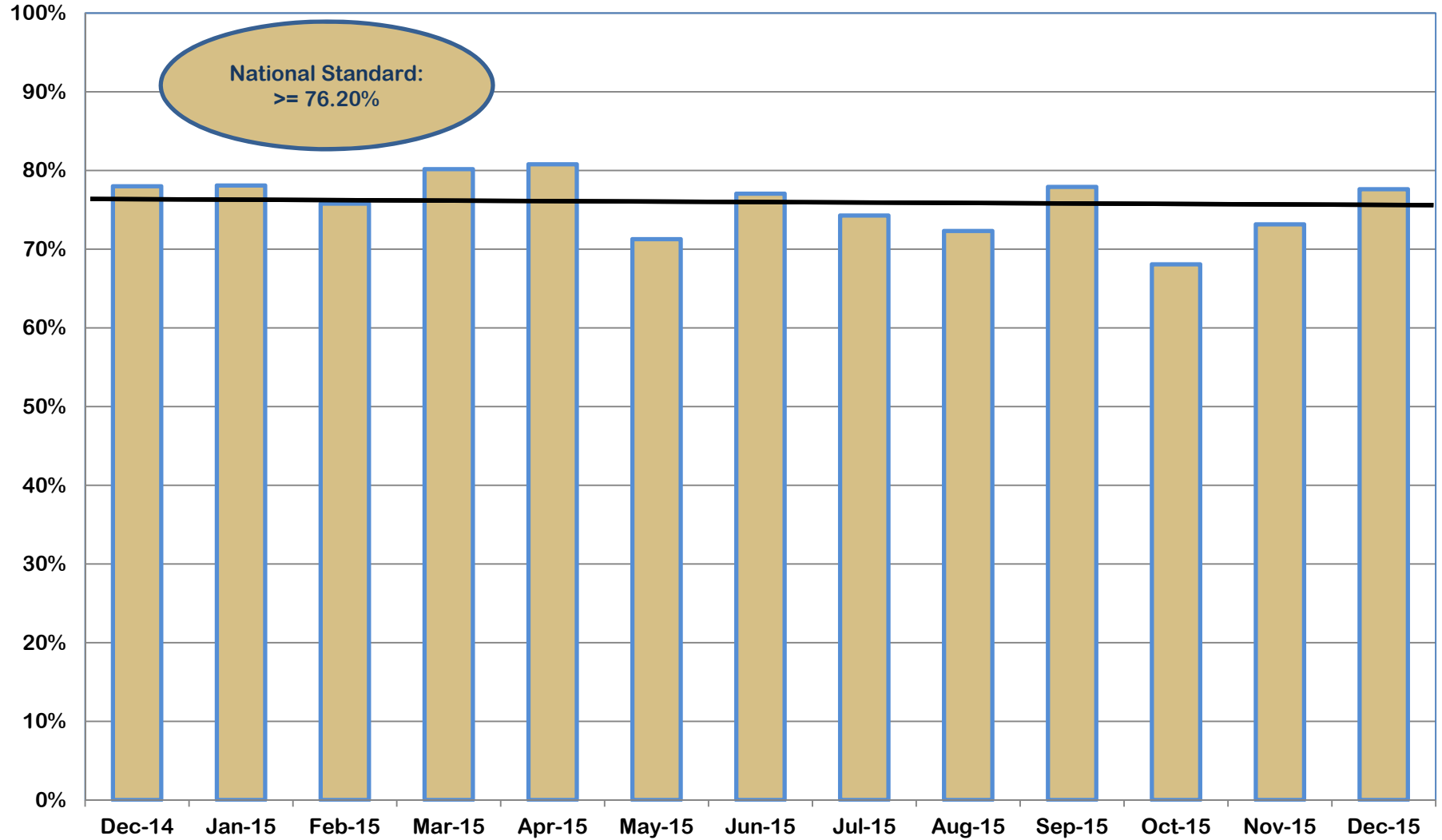

Outcome VIII: Foster Care Length of Stay (December 2014 – December 2015)



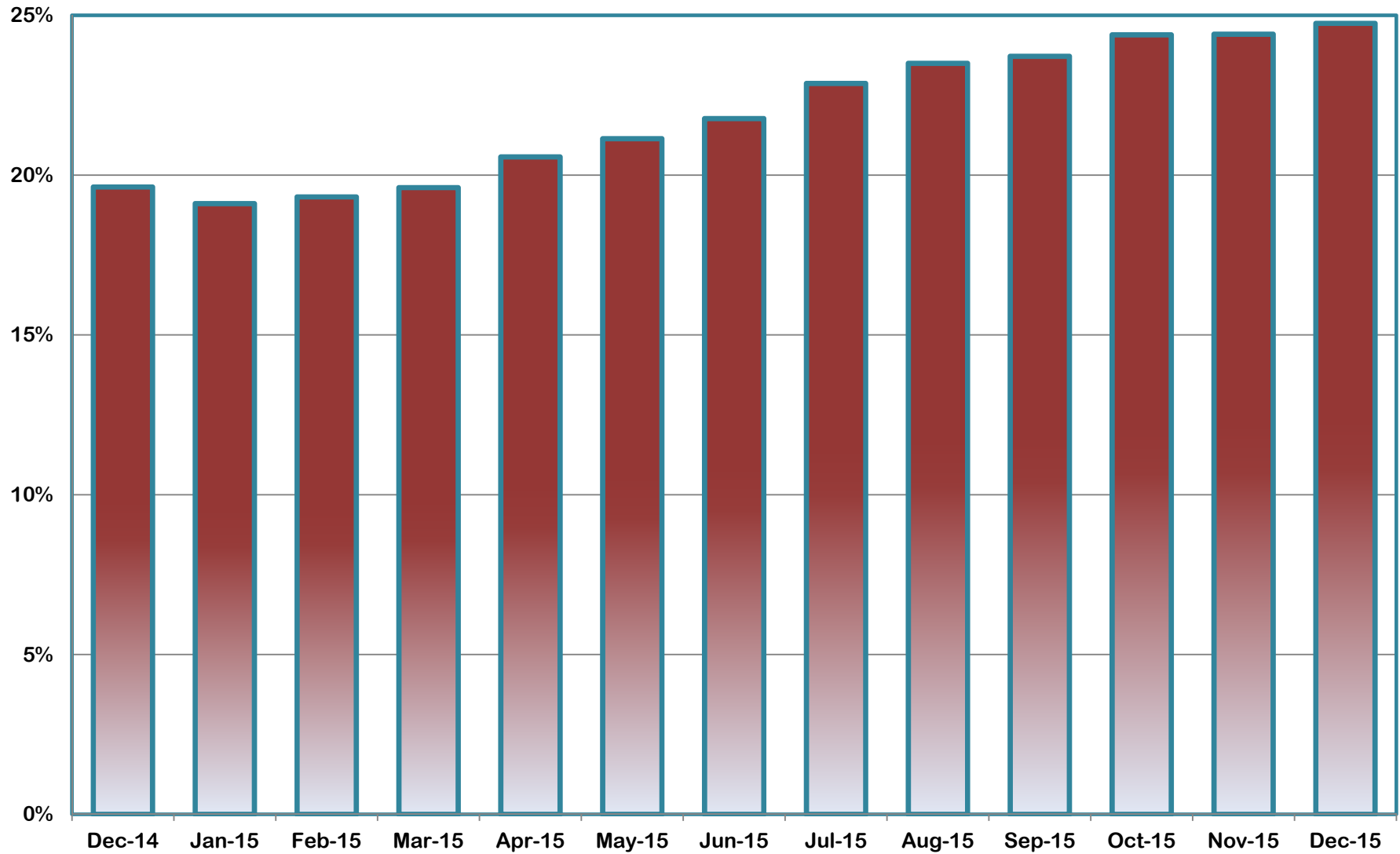

Outcome IX: Length of Time to Reunification (December 2014 – December 2015)



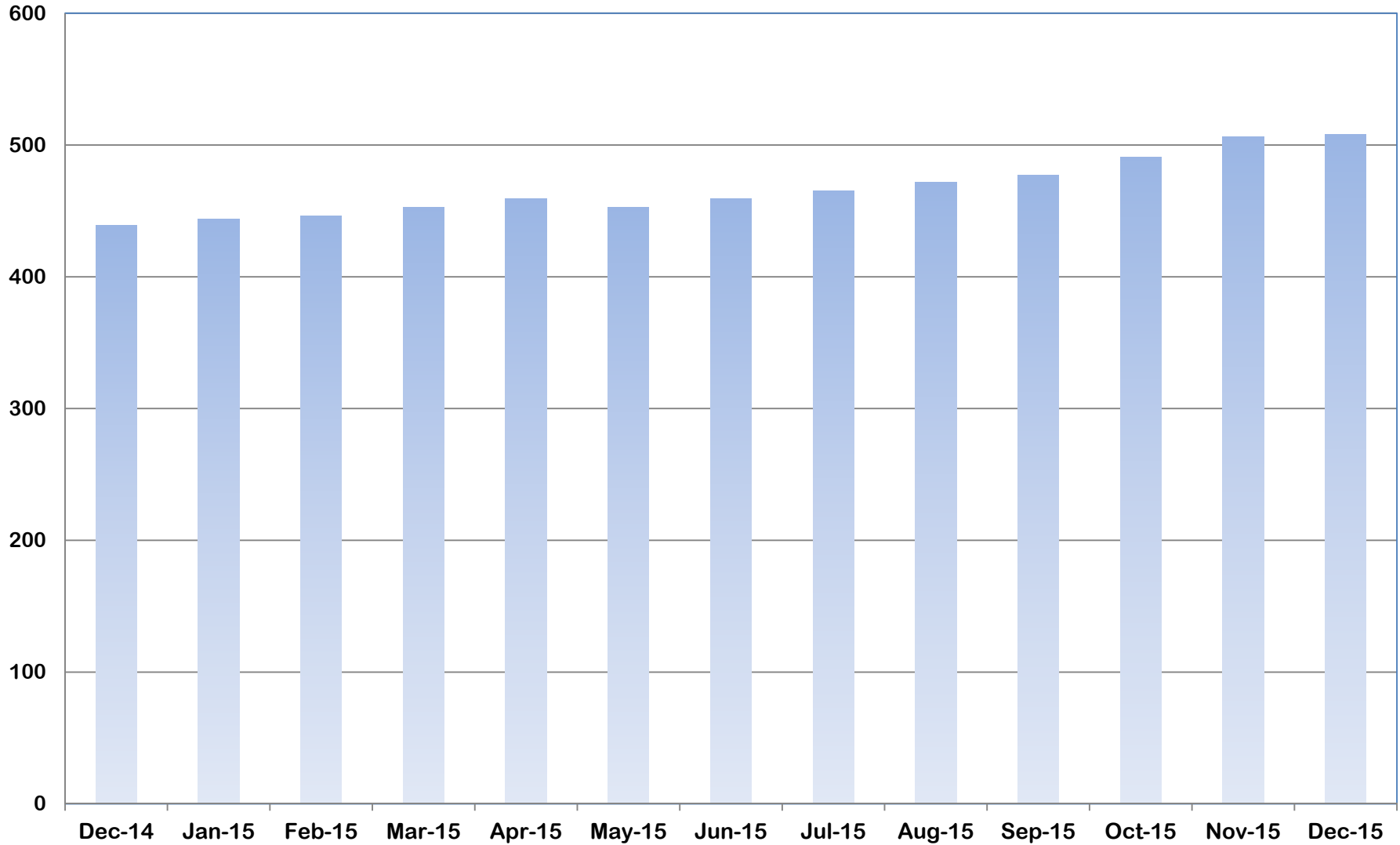

Outcome X: Percent of Children Placed with Relatives (December 2014 – December 2015)



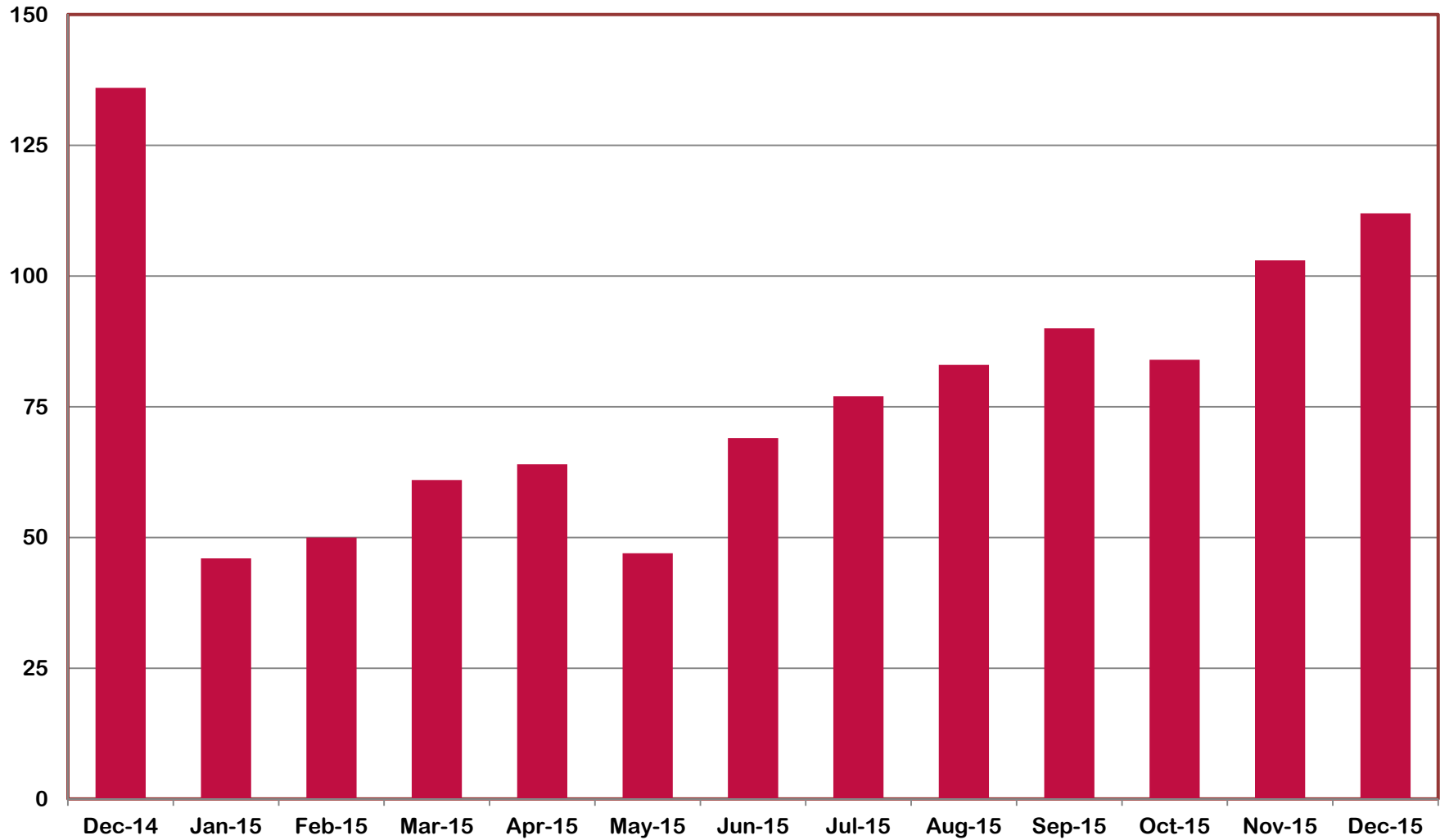

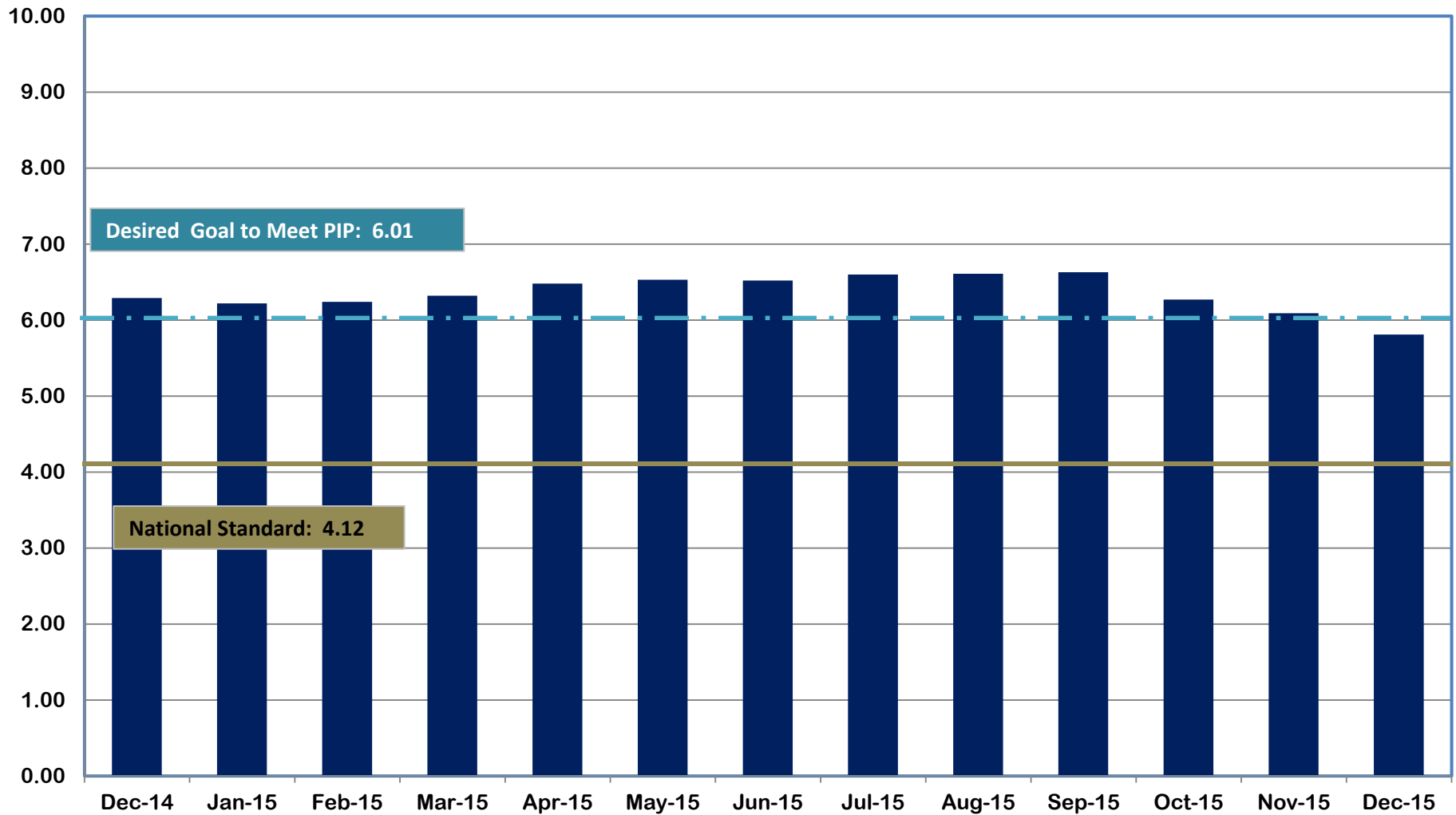
